The URTE program's objective is to encourage private investment in targeted areas of the city by providing an exemption on the increase in property taxes resulting from improvements. The URTE program works as an incentive to help reinvigorate Davenport. The program was established to help soften the burden of higher property taxes that can result from improving a home / property.

The program is divided into three components:

- ◆ **RESIDENTIAL**
- ◆ **COMMERCIAL & INDUSTRIAL**
- ◆ **ABANDONED RESIDENTIAL**

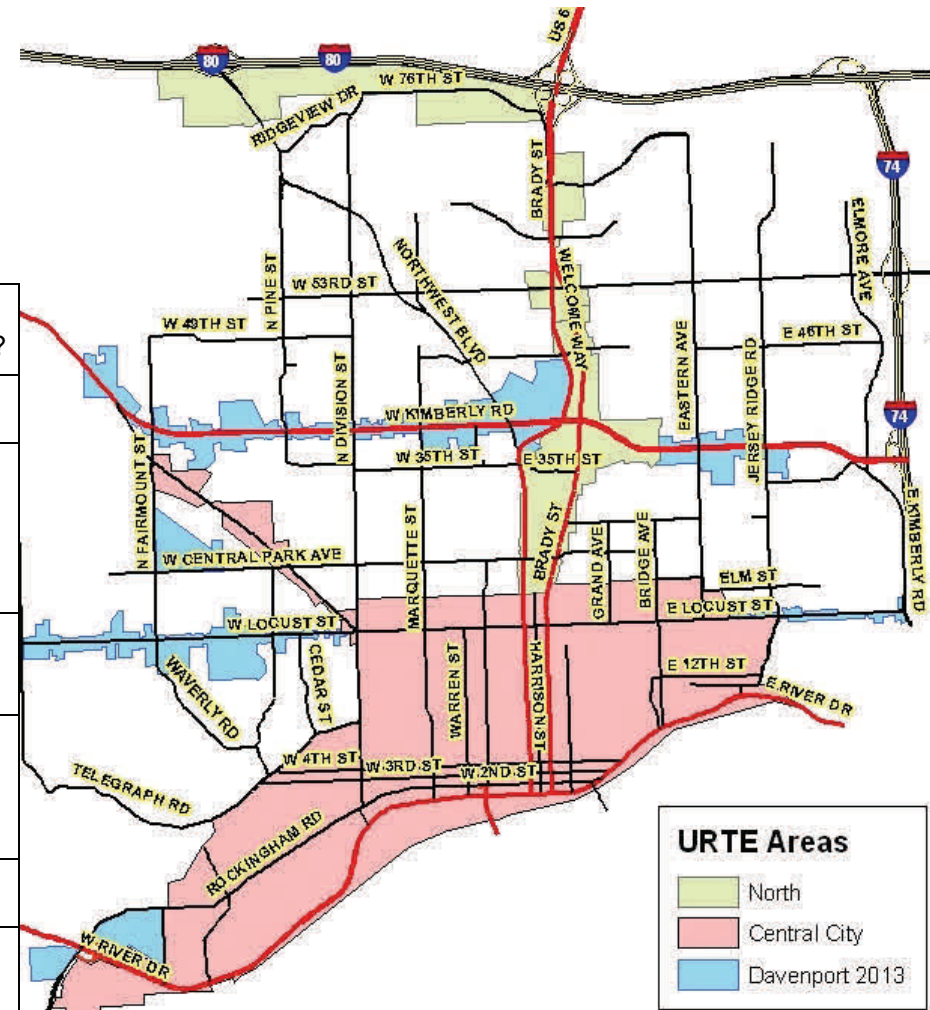

North Corridor:

The North Corridor area provides exemption on renovation and new construction on redeveloped properties.
