

# Davenport NOW

**Receive a property tax rebate when you buy a new construction home or make renovations to an existing property in Davenport!**



Homeowners and commercial property owners can receive a rebate for 50% of the City's share of your property taxes for 10 years based upon your increase in assessed value. Veterans and active military receive a 60% rebate.

## **Three ways to participate**

- ◆ Get your rebate upfront in a single check
- ◆ Receive a larger sum by choosing to collect your rebate over a 10 year period
- ◆ Choose the College Cornerstone choice to utilize your Now rebate for a 529 college saving plan and receive 13 years of benefits\*

## **Key details**

- ◆ Property must be within the city service area
- ◆ The assessed valuation must increase by at least \$5,000
- ◆ City building permits must be finalized & new homes need final certificate of occupancy\*
- ◆ If the home is new, you must be the first owner-occupant\*
- ◆ You must be current on all property taxes and utilities
- ◆ Property deed must be recorded with Scott County to verify ownership
