

## CitiBus Application for Half-Fare Unemployed Individuals

The City of Davenport's CitiBus program offers a program for residents of Davenport who are unemployed to receive the benefit of half-fare for all of CitiBus' fixed route services. To apply for this benefit and receive an Unemployed Half-Fare ID, complete this application and return this form with proof of unemployment to: CitiBus Transit located at 300 W River Drive, Davenport, IA 52801. You may present your application with proof of unemployment during offices hours (Monday through Friday, 8am to 5pm) or mail the application with copies of proof of unemployment.

Proof of unemployment shall be considered a letter from the Iowa Workforce Development Center stating that you are registered and actively seeking employment.

You must be a resident of Davenport to be eligible for this program.

If approved, the Unemployed Half-Fare ID provides the user with reduced fare on all regular daily fixed route services and Saturday morning subscription services.

The Unemployed Half-Fare ID is non-transferable and if presented by any person other than the authorized cardholder, the operator will take the I.D. Card and collect a full fare.

You may only receive one (1) Unemployed Half-Fare ID Card per year.
