



Upon the recommendation of a recognized business in the profession of sewer cleaning or plumbing; verification by the City's Utility Inspector that current plumbing fixtures, drains and sump pump configuration adheres to Davenport Municipal Code 8.15.570; the completion of this form; and payment of a \$500.00 deductible, the City of Davenport is authorized by the undersigned Property Owner to call on behalf of the Property Owner a contractor on the city list to repair their eligible sewer lateral. The Property Owner further understands the repairs eligible to be paid for by the grant under this program are limited to repair of the eligible sewer lateral, backfill and replacement of any sidewalk or street in the city right-of-way; all other items disturbed are the sole responsibility of the Property Owner and not eligible to be paid for by the grant, as are all costs exceeding \$10,000.00 for the eligible repair.

If you do not own the property identified for repair, contact the Owner of the Property. The Property Owner is required to complete this application before work can be authorized and eligible for a grant under this program.

**Eligible Repairs under the Sewer Lateral Repair Grant Program**

- Private laterals serving single family home, townhouse, duplex, condominium or a multi-family building containing not more than three (3) dwelling units.
- Other laterals in the city right-of-way.

**Repairs not covered by the Sewer Lateral Repair Grant Program**

- Any private property improvements (landscaping, driveway, sidewalk, seed, sod).
- Private improvements on right-of-way (landscaping, driveway, seed, sod).
- Septic tank systems.
- Trailer parks (as a commercial enterprise) up to city right-of-way.
- Any damage inside of a building.
- Routine maintenance on lateral such as root cutting, cabling, jetting or televising a line.
- Water lines.
- Repairs needed to adhere to Davenport Municipal Code 8.15.570 (disconnecting sump pump, foundation drains, etc., from sanitary sewer).

**Before Completing this Application**

If a property experiences an issue with its sewer lateral service, such as back-up of sewage into basement, the property owner needs to call a recognized business in the profession of sewer cleaning or plumbing. If they advise that the issue involves a break or blockage in the lateral that cannot be opened, contact the City of Davenport Public Works Department at (563) 326-7923 Monday through Friday, between the hours of 7:00 am and 4:30 pm or visit [www.cityofdavenportiowa.com/pwrs](http://www.cityofdavenportiowa.com/pwrs) and place a request.

**With this Application**

- Property Owners must submit a \$500.00 deductible.

**Other Financial Assistance**

Property owners who need assistance with the \$500.00 deductible required under this program, or to pay any costs in excess of the \$10,000.00 program limit for repairs to the eligible sewer lateral under the City's sewer lateral loan program, may be eligible for other assistance through Davenport's Community Planning and Economic Development programs; contact CPED at 563.326.7765. Note: The City's Sewer Lateral Loan Program can not be used to pay for those items not covered under the Sewer Lateral Repair Program.

Before completing and submitting this form, be sure to coordinate televising of the sewer lateral with the City's Utility Inspector. **Footage obtained in the City Utility Inspector's absence will not be allowed as support for this request.** Contact Public Works at 563.326.7923 to coordinate.

If you have private sewer insurance, such as the insurance provided through IowaAmerican Water Company and its agents contact the City's Utility Inspector for assistance/instruction on filing your claim.
